## **Teaching Philosophy and Context of Teaching Efforts**

I work diligently to ensure that my educational programs are of highest quality and provide useful information to my target audiences, enabling them to make informed decisions and implement best practices and inspiring them to engage in lifelong learning. I tailor each program to the intended audience, invest considerable effort to develop effective learning aids, point students to additional resources, and encourage action. My teaching efforts are prioritized based on a variety of needs assessment techniques, including formal surveys of existing and potential audience groups; interviews with key informants such as professional foresters, agency representatives, and academic peers; and data gleaned from literature. Many of my educational efforts are collaborative in nature, incorporating peers, non-governmental organization and agency partners, and Extension volunteers. I conduct teaching evaluations on a regular basis utilizing the Citizen Evaluation of Teaching (CET), and other, tools. I conduct follow-up assessment of key programs to determine impact.

In the teaching summary that follows, please note that from 2008 through June of 2018 I served as a full-time Extension administrator and had no formal teaching assignment. During this period I developed and delivered educational programs on assessment techniques, civil rights effectiveness, budget development and management, service district formation, and other topics related to my Extension leadership roles, as mechanisms to advance our collective Extension mission. You will also note that I taught numerous plant anatomy and physiology classes. These were delivered to Master Gardener audiences as a way to strengthen my working relationship with that important stakeholder group. The rapport built through these classes was invaluable and allowed me to call upon MGs to lobby on behalf of Extension during state and local budget processes, and to advance Extension's mission in myriad fashions.

July 1, 2018 - Present

FNR faculty work in, and guide educational activities for youth and adults, in forested landscapes that have objective hazards and may be difficult for emergency services personnel to reach.

A safety committee was formed with the commission to develop safety protocols for field activities, and identify and address training and equipment needs.

Safety standards were developed and shared among colleagues. A survey of training and equipment needs was conducted. A wilderness first responder course has conducted in April 2019. Advanced first aid and epinephrine classes were offered at the summer FNR meeting. Specialized first aid kits were developed, assembled, and distributed (16 full kits, 16 personal kits). 18 additional large kits have been requested and are being assembled. AED options were researched and 13 units purchased for FNR and Fire field faculty (with 6 more planned for next year).

The field safety protocols were presented at the UIFRO Extension Knowledge Exchange conference in Christchurch, New Zealand, September 2019.

"Extension Education in the Forests and Fields: How Safe Are We?". (December 2019 - Present)

Determine the frequency and types of injuries, and their causes, incurred by participants in Extension education programs conducted outdoors, related principally to forestry and natural resources. -

#### Issue

OSU's Agriculture and Natural Resources (ANR) Extension Program implemented working groups to enhance and expand local, regional, and statewide programmatic impacts. Up to 30 working groups, based on expertise and the way they serve Ag commodity groups, were developed in early 2017. Working groups were mandated as the means of creating projects/programs that have both local and regional applications and use. Impactful programs require careful planning and participation by everyone in the group. However, a major obstacle was that many ANR faculty had no formal training on team-oriented program planning. The College looked at the successful planning process used by the Forestry and Natural Resources Extension Program and asked Dr. John Punches to lead a program planning process for three working groups: Beef, Forages, and Dairy working groups. [Information submitted by Dr. Sam Angima, ANR Program Leader]

#### Action

Dr. Angima scheduled a joint meeting of the Beef, Forages, and Dairy working groups for September 25-27, 2018. Participants were assigned prerequisite reading to familiarize them with the FNR planning process. Statewide specialists were asked to prepare and share statewide goals on issues within their scopes of expertise. At the meeting, Dr. Punches described the FNR planning process and discussed how it could be adapted to ANR. He then led the combined working groups through needs identification and project proposal development. This was followed by teams presenting proposals to their colleagues, and Dr. Punches coordinated voting and prioritization of projects. The process concluded with participants committing time (FTE) to one or more of the six selected projects. Group project leaders were identified and commissioned to develop detailed group project descriptions for consideration by the Program Leader.

### Outcome

All six groups submitted project descriptions by the November 1, 2018 deadline. In response, Dr. Angima allocated funding as follows:

- \*Enterprise Budgets: \$8000
- \*Cattle reproduction education model: \$10,915
- \*Oregon Beef Quality Assurance Extension Program: \$10,000
- \*Google Earth Pro-Geographic Information Systems Hybrid Extension Curriculum: \$6,500
- \*Forage ID Workbook: \$7,100
- \*Water use and Irrigation: \$10,000

Each group committed to meet their project objectives by October 1, 2019, and are responsible for submitting quarterly progress reports.

The working groups agreed that the FNR planning process was effective at helping them identify collaborative projects that address clientele needs, and have indicated a desire to replicate the process at their next annual meeting.

#### Issue

In 2010, the Lane County OSU Extension Office lost its county funding following an unsuccessful attempt to pass a local option tax. Lane Extension had a long history of public support through serial levies (the predecessor to local option taxes), but the 2010 effort failed to garner public acceptance. In response, OSU reassigned 4-H and Forestry faculty to other offices. The Agriculture program was allowed to remain in place under grant funding, as was the Nutrition program. Dedicated volunteers agreed to keep the Master Gardner and Master Food Preserver programs in place, under the condition that they be self-supporting. The county government, no longer able to provide office space, chose to demolish the aging Extension building. The remnants of Extension moved to a small suite of spaces leased from a local construction company.

While the determination of Lane County's Extension volunteers and remaining faculty members was (and is) notable, the situation was untenable. Each remaining program area was, of necessity, heavily focused on revenue generation. Volunteers spent much of their time fund-raising, rather than conducting community educational outreach. Each program area was focused on its own success, dramatically diminishing the sense of community and collaboration characteristic of "healthy" Extension offices. Extension's reputation within Lane County had been damaged during the local option tax campaign, and many persons (even many long-time supporters) assumed that the tax measure failure meant Extension had disappeared from the county.

This sense of separation was heightened with respect to the relationship between Extension at the county level and Extension at the state level. Faculty and volunteers in Lane County felt abandoned at best, and many felt that "OSU" was actively out to terminate the Lane program.

To sum, Lane Extension was underfunded, heavily focused on revenue generation, occupying a small office space with no teaching facilities, its program areas were separated both physically and because of the competitive nature of fund raising, and faculty, staff, and volunteers were experiencing a sustained high level of uncertainty-induced stress. Everyone was waiting for the shoe to fall...

#### <u>Action</u>

In July, 2011, OSU combined Lane County with the SW Oregon Extension administrative region, and that Regional Administrator (RA) was asked to make a concerted effort to rebuild capacity and effectiveness in the Lane unit. As part of the negotiated arrangement, the RA requested and received broad latitude to run the Lane Extension Office in an entrepreneurial manner, and to take actions necessary to rebuild trust and unity (both among the office's employees and volunteers, and between those persons and OSU/campus). Key actions included:

- •Purposeful engagement by the RA with faculty/staff/volunteers to garner trust and demonstrate both commitment and value. In many cases, this engagement included physical work alongside volunteers, and/or teaching in support of volunteer programs.
- •Careful budget tracking and forecasting, at both the office-wide and program area levels, to identify funding needs, extent of fundraising required, and sustainability of programs and services.
- •Identifying areas of common needs and goals, and negotiating among program areas to arrive at mutually beneficial staffing and facilities access.
- •Conducting a detailed needs assessment that specifically looked beyond existing clientele. The assessment was carried out by the University of Oregon Community Planning Workshop, and worked with wide range of Lane County service providers to identify Extension's niche. To our surprise, these organizations and government entities consistently encouraged OSU Extension to remain focused on its traditional areas of strength (4-H Youth Development, forestry and agriculture outreach and applied

research, nutrition, food preservation and safety, home gardening, family financial guidance – with emphasis on youth and older adults, and high quality volunteer capacity), rather than shifting into "new" areas. Their argument was that, collectively, Lane County has a strong and diverse system of service providers, but that no other provider replicated the expertise of OSU Extension Service. Should Extension disappear, or shift its emphasis, the county's network of services would have been left with an Extension-shaped hole.

- •Re-initiation of 4-H in Lane County, under a Community Club model, with assistance from SW Region 4-H faculty and staff and nearly \$200,000 in private donations and grants.
- •Negotiation of a low-cost lease of a historic property from the City of Eugene, which was then extensively remodeled with volunteer labor guided by pro-bono expertise from a local contractor and architectural firm. This included interior painting, office traffic flow improvements to better accommodate handicapped persons, flooring refinishing and upgrades, lighting improvements (for light quality and efficiency), repair of handicapped access lifts, creating a more open office space for secretarial staff, improved heating and cooling, extensive landscape improvements, construction of a permeable parking area, creation of educational murals, rainwater gardens, and educational raised beds. Funding for these improvements came from private donations and numerous small grants.
- •A concerted (and lengthy) effort to garner county commissioner support for another attempt for a local option tax to fund Extension in Lane County. The effort included a clear message (keyed to the needs assessment) and a carefully articulated and fully defensible budget. The RA secured commitments from the Forestry and Agriculture programs to refill key faculty positions in the county, pending success at the polls. The RA and Extension faculty/staff conducted numerous public education events to demonstrate Extension's value, and a Political Action Committee comprised of dedicate community members/volunteers made the appeal for a positive vote.

#### Outcome

By June 30, 2018, Lane County Extension had become a much different organization:

- •Physically located at Kaufman House, with a 30-student teaching space, a newly completed Master Gardener clinic, a client reception area at the main entrance, ADA-accessible main and lower levels, extensive teaching gardens and demonstration areas, large commercial quality kitchen space for teaching and nutrition program support.
- •Local option tax funding passed successfully in 2016, leading to nearly \$438,000 of funding in fiscal year 2017 and over \$475,000 in fiscal year 2018 (with 3 additional funding years authorized).
- •Thriving forestry and natural resources program led by a new faculty member (OSU funded)
- •Innovative commercial horticulture program led by a new faculty member (50% OSU funded, 50% local option tax funded)
- •Growing 4-H youth development program, with both club-based and natural resource emphases (faculty member OSU funded, program assistant local option tax funded)
- •Small Farms regional position housed in Lane County (OSU funded)
- •Restructured and growing nutrition education program (OSU funded through federal grants)
- •Additional staff position (local option tax funded) focused on new audience outreach via social media
- •Master Gardner program reach expanded to outlying communities through mobile plant clinic
- •Master Food Preserver program very active and conducting educational programs throughout the county and in conjunction with the Siletz Tribal government

Perhaps most importantly, Lane Extension had become a unified group, with a collective commitment to innovative community education. Faculty, staff, and volunteers shared a high level of trust in each other, and worked collaboratively to support each other's programs. Lane Extension's entrepreneurial nature was still prevalent, but gone was the sense of competition between program areas and volunteer groups – Lane Extension had become a team.

We collectively attribute the change to shared commitments, belief in our common mission, and the willingness to work hard and go beyond the call of duty to meet the needs of Lane County residents. Notes:

#### Issue

Forest landowners in NE Oregon face the ramifications of nearly 100 years of fire suppression. Facing marginal timber prices, landowners require financial assistance to carry out much needed fuels reduction and forest thinning practices on private properties. Much of this assistance comes through the efforts of the Natural Resources Conservation Service working in cooperation with the Oregon Department of Forestry. Accessing this financial aid requires landowners to have current, written forest management plans. In NE Oregon adequate amounts of financial aid were available, but professional forester capacity was insufficient to meet the management planning requirements.

#### Action

I co-led an effort to develop and deliver workforce training to expand regional capacity to write forest management plans. Partners in the project included Wallowa Resources (a regional natural resources non-governmental organization), Oregon Department of Forestry, the Natural Resources Conservation Service, and several area consulting foresters. Four persons were recruited through a competitive process to complete the job-training program, at then end of which they became recognized as forest management plan-writing technicians. They received 48 hours of specialized training to familiarize them with NE Oregon forest types and conditions, landowner interaction techniques, and management plan requirements and sources of information. They were provided with customized tools including a streamlined management plan template and a GIS-referenced data collection app, along with reference materials. Following training, they were paired with experienced plan writers who served as mentors while they crafted three training plans each.

## Outcome

All four candidates completed the training, including their training plans. Three of the four have, to date, affiliated themselves with area consulting foresters and are assisting in development of additional plans. This is a significant increase in professional capacity, and we anticipate it will meet the plan development needs for the next several years. At the end of 2019 (6 months after the program's initiation) the technicians had helped complete 25 forest management plans. (For comparison, during the same time period the Oregon Department of Forestry reported completing 21 plans.) Over the next three years we expect these technicians to be active in meeting the need for approximately 270 plans within NE Oregon. Landowner feedback to date has been exceptionally positive, with many references to the plans' concise format, highly visual nature (they include photos showing current and desired stand conditions), and easy-to-understand forest management recommendations. The "basic" forest management plan template developed in this program has been shared broadly and we have been invited to add it as a resource on the Oregon Forest Management Plan resources website.

### Diversity, Equity and Inclusivity

This training was designed to be accessible to persons at all career stages. As a result, the cadre of successful applicants ended up being young mothers who had left prior natural resource careers to start families. The program structure, which included compact training days, a generous stipend, and flexible mentored experiences, provided a mechanism for them to re-enter their career fields.
